- 1 - The Principal extended a warm welcome to all E-PTA members.
- 2 - Principal briefed about the best practices of the school, ongoing and future initiatives of the school as well as achievements of the school.
- 3 - Followed by it, coming to the main agenda of the E-PTA meet, Compliance of E-PTA meet held on 18th August 2021 was given.
- 4 - Students' feedback analysis for class VI to XII was presented. Students' satisfaction index is highly praiseworthy and motivating for the school.
- 5 - Upcoming events of the session 2021-22 were introduced to all E-PTA members.
- 6 - Details of the school outstanding fees for session 2019-20, 2020-21 and 2021-22 was presented and an appeal was made to all E-PTA members to extend their contribution in collection of school outstanding fee.
- 7 - The Management of school has informed to the EPTA members, that as a difficulty raised due to prevailing

Covid 19 Pandemic in resumption and conducting of physical classes in the school, though a fees increase of 16.5% over the fees applicable for the academic year 2019-20 was approved for the academic year 2020-21 & 2021-22 but the school Management has not increased the approved fees increase of 16.5% for the academic session 2020-21 and has charged the same fees as was charged in academic year 2019-20.

8 - Considering the fact that the Covid-19 pandemic has had its damaging effects on the financial condition of several families and to enable the parents to ensure a smooth flow of education of their wards and regular payment of fees to the school, the management has considered the request of parents sympathetically and has granted a waiver of 10% in the fees for the Academic Year 2020-21.

9 - Further to above, the management has allowed a waiver 16.5% equal to approved increase in the fees for the academic year 2021-22 solely on humanitarian grounds.

10 - In the open session an appeal was made to all EPTA members to share their opinion regarding conduction of online classes. A lot of positive

feedback for the same was given by many EPTA members. However, the EPTA member of std. VIII and IX appealed to conduct offline classes for std VIII and IX everyday instead of conducting offline classes on alternate days.

- 11 - School Management has proposed the increase in School fees by 15% over the fees applicable for the academic year 2021-22. The above proposal has been considered by the Executive Parents Teachers Association (hereinafter referred to as "EPTA") keeping in mind the various factors mentioned in section 9 of the Maharashtra Educational Institutions (Regulation of Fees) Act 2021 (hereinafter referred to as "said Act") and has approved and agreed for 10% over the fees applicable for the Academic Year 2021-22. This approved fees will be applicable for the academic sessions 2022-23 & 2023-24.

Though the above increase of fees has been approved by the EPTA, in case of any difficulty in resumption and conducting of physical classes in the school, the School Management shall consider granting waiver of 3% in fees. The said waiver is being offered considering the experience, relating to utilization of various facilities, services, etc. during the previous period of Covid 19 pandemic.
